- All medical cards

- Copy of Mortgage Statement – if applicable. Sale of home documents if sold within the past 2 years
- Divorce Paperwork if within 5 years
- Power of Attorney (POA documents)

## **Medicaid Important Information**

Medicaid takes approximately 10 months for approval. The amount we get paid toward rent is \$690.00 per month. The difference in the rent is paid by the resident as we do not reduce the rent for low income.

## **Aid and Attendance VA benefit**

This benefit is for veterans, their spouses, and widowed spouses of veterans. Remarriage or divorce severs the spouse award. Program pays retroactive months of funds when awarded up to 12 months. We will connect you with Patriot Angels for assistance with the application.

It is not service connected, it is a benefit to reimburse care needs of aging and disability through disease, injury, and age-related mobility.
